

2018 Tentative Customer Bill Schedule

The 2018 Utility Bill Schedule is produced to inform our customers of their utility account billing date and payment due date. Customers will be issued six bi-monthly bills for 2018 service.

Failure to receive bill does not relieve you of the obligation to pay bill.

How to read this schedule:

1. **Cycle** refers to service area (cycle numbers are found at the top of the bill above meter readings).
2. **Bill date** is the date the bill is generated and mailed to the account holder.
3. **Due date** is the date payment is due in our office (20 days after the billing date).

*Sewer cap – Sewer charges shall be limited to the base charge, plus consumption charges up to 50 units of water used through any such meter regardless of purpose of use.
