Scope and Content:

Series 5100-027, Savannah Fire and Emergency Services Bureau Records, Visual Materials-Photographs (circa 1880s-circa 1998, no date), includes color and black and white photographs as well as photocopies. The items in this series include images of stations, training events and aerial photographs. Some of the photographs were taken by members of the Savannah Fire and Emergency Services Bureau. However, many of the older photographs were given to, or collected by, the Fire Department over the years.

System of Arrangement and Ordering:

This series has been arranged in eight sub-series by subject:

- Sub-Series 1 Aerial Photographs
- Sub-Series 2 Equipment (vehicles, alarm paraphernalia, apparatus, etc.)

Scope and Content:

Record Series 5100-027 Addenda, Savannah Fire and Emergency Services Bureau Records, Visual Materials—Photographs (circa 1980s-1990s, no date), are photographs of artifacts relating to the Savannah Fire Department. There is one photograph of an old Savannah Fire Department badge and there are photographs of a silver speaking trumpet. Both items are privately owned and the Fire Department was only able to obtain photographs of the items.

The badge was found in a river and the owner wrote to the Fire Department hoping to obtain more information about it. This letter and notes from the Department are included in the folder with the photograph. The speaking trumpet is an example of early communication equipment. The trumpet served as a mega horn, used by chiefs to give instructions at the scene of a fire. These trumpets could also be ceremonial, an indicator of rank, or given as a trophy. No other information is known about either the badge or the trumpet.
