**RESIDENTIAL PARKING DECAL INFORMATION**

The information below outlines the requirements for residential parking decals according to the Savannah Code, Section 7-1072, and the Revenue Ordinance, Article J, Section 1(D). The purpose of a residential parking decal is to allow residents FREE on-street parking in metered spaces, with a maximum of three decals per residence.

***THE RESIDENT MUST PHYSICALLY LIVE AT THE RESIDENCE TO QUALIFY FOR A RESIDENTIAL PARKING DECAL. ANY FALSIFICATION OF INFORMATION WILL RESULT IN THE PERMANENT REVOCATION OF THIS PARKING DECAL.***

**Homeowners:** The following documents must be presented with his/her name & address to qualify.

- Warranty deed or settlement statement (for new properties only)
- Current property tax bill (Renewals Only)
- Current Chatham County vehicle registration showing the downtown address on the registration.
- Current gas, electric, or water bill (30 days)
- Decal will expire five years after the tag registration date.
- **All three documents are required: tax bill, utility bill, and current registration.**

**Leasing/Renting:** ALL the following documents must be presented with his/her name & address to qualify.

- Current lease agreement: the original copy must be typed without alterations and signed by all parties. AND
- Current Chatham County vehicle registration showing the downtown address on the registration. AND
- Current gas, electricity, and water (30 days) AND
- The decal will expire when the current vehicle registration ends.

**Renewals:**

- Applicants must submit all current information to renew their decal for the upcoming year.
- Parking citations issued due to parking decal expiration will not be dismissed and must be paid in full before renewing and/or receiving a new decal.

**Permit Restrictions:**

- Applicants must park within their designated zone. Broughton Street residents are not allowed to park on Broughton Street except in the Blue Zone Residents area (Lincoln Street to East Broad Street).
- Vehicles are not allowed to park at 15 or 30-minute meters.
- Vehicles are not allowed to park in front of commercial establishments.
- Illegal parking is not allowed; this also applies to posted street sweeping zones.

**Display of Decal:** Decal must be affixed to the inside **FRONT** driver's side windshield at the bottom.

**Change of Residence:** If the applicant relocates, the parking decal becomes invalid.

**Miscellaneous Information:**

- Residents with company vehicles must present a statement on company letterhead verifying the vehicle is used by the applicant at that residence
- Applicants must present a rental agreement for rental vehicles
- Current company vehicle registration
- Mobility & Parking Services may require a property inspection to verify residence.
