Approval of Minutes

Mrs. Paul motioned to approve the minutes from October, Mr. Tanner seconded. Vote: seven in favor, zero opposed.

Needs Assessment Reports

East 39th Street: One segment qualifies on speed; one segment qualifies on volume. Mrs. Paul motioned to approve, Mrs. Atkinson seconded and the motion was carried.

Garey Avenue: Qualifies on speed. Mrs. Paul motioned to approve, Mrs. Atkinson seconded and the motion was carried.

Arcadian Street: Low volumes, however it qualifies on speed. Fairly long block with stop control. There are concerns about splitting up the block because it only qualifies on one of the two segments, the initial run off Liberty Parkway Identified as a cut-through by Mr. Rountree. Mrs. Paul motioned to table this discussion, and Mr. Tanner seconded.

Montclair Boulevard: Does not meet on speed. Mr. Tanner motioned to deny, Pastor Buford seconded.

200 Block East 38th St: Missed on speed, Pastor Buford motioned to deny, Mrs. Atkinson seconded.

East 44th Street: Does not qualify on speed. Mrs. Atkinson motioned to deny, Mr. Tanner seconded.

Early Street: Motioned to table by Mrs. Paul until school is not in session. Mrs. Atkinson seconded.
Needs assessment tabled.

New Applications

600 Block West 42nd, 1200 Block East 50th, 300 Block West 54th: Determined there's nothing impeding and they qualify on length. Pastor Buford motioned to move forward for assessment. Mrs. Atkinson seconded. These three applications move forward for assessment.
