PERMIT IS SUBJECT TO THE FOLLOWING STANDARD CONDITIONS:

- 1. A Dumpster/Container permit fee is hereby established and required for refuse dumpsters, office trailers, utility/storage trailers or containers, and other such vehicles or structures placed on public property at construction or service sites, thereby making parking spaces or other public areas unavailable for use.
2. In addition to the \$20 application fee, the rate for each Dumpster/Container permit shall be four dollars (\$4.00) per equivalent parking space per day, whether such space is metered, unmetered, marked, or unmarked, whether on the street or in alley (excluding Sundays and holidays).
3. The Traffic Engineering Department shall collect permit fees and issue Dumpster/Container permits upon the approval of the location. Any contractor or other person placing a refuse dumpster, container, trailer, or other vehicle or structure on public property shall take out and pay for a Dumpster/Container permit at the Traffic Engineering Department, located at 1100 W. Gwinnett St., and shall display said permit in clear view on or near the permitted vehicles or structures.
4. There shall be a ten dollar (\$10.00) penalty fee added to the cost of any permit issued as a result of City enforcement action. Any person violating this Article shall be subject to subpoena to Recorder's Court and fines resulting there from. Each incident and/or each day shall be deemed a separate violation.
5. Applicant is responsible for the protection of paved surfaces when loading and unloading operations of dumpster. Three-quarter inch (3/4") plywood is required under runners if placed on pavement. Applicant will be held liable for any roadway or sidewalk damage caused by placement of dumpster/container. Per City Code Section 4-2022.
6. No dumpsters will be permitted in the sidewalk area. Only upon special provisions will the use of sidewalks be allowed. Under these situations applicant will be required to protect the integrity of the sidewalk and provide temporary ramp to drive onto sidewalk.
7. Dumpster shall be covered when not in use to prevent debris from blowing onto right-of-way.
8. The City right-of-way surrounding the dumpster shall be kept free of debris.
9. No degradable materials shall be placed in dumpster.
10. Dumping materials into the dumpster from higher elevations requires a covered chute to minimize dust.
11. Dumpsters or containers that are next to roadway shall be provided with reflective red and white tape diagonally striped six inches (6") in width and twenty-four inches (24") in length (as a minimum) to be located at each corner on the top side of dumpster or container.
12. Applicant assumes all liability and holds harmless the City against all claims, damages, suits, fines and liability for injury or death to persons or loss or damage to property related to the placement of a dumpster/container in the City right-of-way.
