Administrative History:

The Oglethorpe Marble and Granite Company is a family-run business that has produced multiple public and private monuments, church altars, markers, and more in Savannah, Georgia for over a hundred years.

The Oglethorpe Marble and Granite Company was established in 1907 by George Bernard, “G. B.” Little (1873-1929), in Savannah, Georgia. G. B. moved his family to Savannah from South Carolina around 1900. He was married to Eva Hortence Buckner Little (1874-1939) and had two sons, George Little, Jr. (1900-1988) and Milton J. Little (1906-1984). G. B. first worked at Savannah Marble Works as a stonecutter, but then wanted to start his own company using more modern techniques. The Oglethorpe Marble and Granite Company was the first established modern marble company in Savannah. They were the first Savannah marble company to use plate letters and the first to have a sandblasting machine to cut the material.

The company set up shop at the Central of Georgia Railroad Yard on West Broad Street (now Martin Luther King, Jr. Boulevard) in 1908. Oglethorpe Marble then acquired their first marble business, Dixie Stone Company, on January 10, 1912. After this merger, the company moved in 1912 to an old Dixie Company stone yard located at Harmon and Wheaton streets. G. B. involved his family in the business heavily and hoped to pass it down through the generations. George, Jr. was not very interested in stone cutting, but Milton was interested in the business, so much so he created his first monument at the age of eleven. Milton and his father moved the business several more times but eventually established their stone yard on Waldburg Street near East Broad Street in the 1920s. The office is still operated out of the Little residence on 38th and Abercorn streets. Milton took over the business after his father’s death in 1929.

Oglethorpe Marble and Granite Company was involved in designing, manufacturing, or installing all the monuments on Bay Street, except for the Salzburger monument. They have completed numerous projects all over Savannah and Southeast Georgia, and their work has been shipped as far north as Massachusetts and as far south as Florida. Their monuments can be found in downtown Savannah squares, medians, cemeteries, churches, and parks. They have worked on the restoration or installation of all the monuments in Savannah’s downtown historic squares.

One of the more challenging monuments in their portfolio was the Vietnam Memorial, dedicated on June 29, 1991, which had to be shipped as three quarry blocks of Georgia marble and then carved on site. The Company worked on many private and family monuments to tell the story of

one's life after death. Other projects the Company took on included church altars and baptismal bowls. Their work is highly visible all over Savannah.

The Oglethorpe Marble and Granite Company is currently operated by Milton's daughter, Virginia Mobley (1944-). Virginia married Daniel Herman Mobley (1941-2020) in September of 1962, and Daniel Mobley eventually took over the business from Milton after his death in 1984. Daniel continued the work of his in-laws until his death. Now Virginia continues the family business that was started by her grandfather over one hundred years ago. The Little family is buried at Bonaventure Cemetery and the Company's stone yard is still located at 918 East Broad Street.

Scope & Content:

The Oglethorpe Marble and Granite Company records contain business records, photographs drawings, and printing plates. The records, including financials, correspondence, oversized detailed plans, and newspaper clippings, reflect the work of the Oglethorpe Marble and Granite Company on private monuments in cemeteries, monuments for private institutions, and public monuments around Savannah. Numerous photographs and negatives show headstones and individual memorials installed at local cemeteries. There are also photographs of workers installing monuments and the stone yard where material used to make the monuments was stored. The business records detail the financials and specific documentation of projects. The project files are unique in that they contain photographs, correspondence, and news articles about the installation of various monuments. One of note is the project file for the commission of the grave for Johnny Mercer, which includes Polaroid photographs of the tomb's engraving and correspondence with the Mercer family after his death on the design of the tomb, like that of his father's George Anderson Mercer in Bonaventure Cemetery, 1978.

System of Arrangement & Ordering:

The Oglethorpe Marble and Granite Company records are arranged alphabetically by subject into the following format categories. It should be noted that plans for one monument could be in multiple boxes, for example there could be a hand-drawn sketch of the monument, a photograph of the finished product, and correspondence regarding the project. A thorough search under each category will yield results in multiple boxes for one project.
