This record group includes miscellaneous papers such as petitions, bids, license requests, complaints about taxes and tenants, regulations at City Market, lawsuits, and wharf and dock problems. A variety of committees are represented, both regular committees and special committees, including: Committee of Free Holders; Sanitary Commission; Committee on Streets and Lanes; Committee on Water; Market Committee; and Health and Cemetery Committee. Because this record group is miscellaneous, a variety of types of documents are included by the Clerk of Council in this category. It is advisable to check this group if researching a deed or contract, as well. If a piece of paper was handled by the Clerk of Council, it appears to have been numbered and filed.

How to Use This Index:

This index will help you discover Miscellaneous meeting papers included in the City Council Meeting Papers – Miscellaneous Collection. It lists the meeting papers by keyword, alphabetically by the first letter of the keyword, and then numerically by deed number. For example, all the “A” Keywords are grouped together. Within each letter, the index is arranged by item number from smallest to largest.

Tips:

- Sometimes there are more entries for a letter than there are lines available on the page, leading to the extra entries being recorded in a different place in the index. Be sure to check the document thoroughly for any overflow entries.
- Meeting papers may be cataloged by several keywords (ex: by a person’s name AND the location). Brainstorm as many keywords as possible for best results.
- The lower the item number, the earlier the deed was created. To narrow down the date of the deed, cross reference its number with the Finding Aid (available here: <https://www.savannahga.gov/DocumentCenter/View/538/Miscellaneous-1849-1930?bidId=>)
