The City of Savannah Alcoholic Beverage Ordinance, SECTION 6-1219, Lawful Presence of Persons under the Age of 21 on License Premises.

In establishments where no less than 50% of the licensee's annual gross sales are derived from the sale of prepared food, provided; however, that during the time the establishment is open to the public its mode of operation remains unchanged and full menu service is available, and further provided that persons under the age of 21 at no time shall be permitted at the bar.

In establishments where less than 50% of annual gross sales are derived from the sale of prepared foods only live entertainment is available, provided; however, that only persons above the age of 18 shall be permitted upon the premises during live performances, for which he or she had paid an admission charge, and only following issuance of a Class I license. In no event shall persona below the age of 18 be permitted on the premises of an establishment that derived less than 50% of its annual gross sales from the sale or prepared foods.

Sunday Sales Affidavit

I hereby affirm that I understand that the privilege of selling alcoholic beverages on Sundays from 12: 30 p.m. until 2:00 a.m. (*Monday*) requires a valid alcoholic beverage pouring license, and that at least 50% of the license establishment's annual gross food and alcoholic beverages sales must be derived from the sale of prepared meals and food. I hereby affirm that I understand that records of food sales and alcoholic beverage sales must be prepared and maintained. Failure to comply with Sec. 6-1211(c) may result in revocation of the licensee's Sunday sales permit. I understand that the City of Savannah may audit our records to verify the same at its discretion.
